***"10 Years of the PPF"***

Moving away from the April pension changes our second speaker on the Friday morning is David Taylor from PPF. The PPF has evolved significantly since it was set up in 2005 as the lifeboat for the underfunded retirement schemes of insolvent employers. It now has over 200,000 members and has paid out a total of £1.6bn in compensation, to date. David led the development of the PPF's 2015-18 strategic plan which in the coming year "includes developments in PPF's approach to customer experience, levy payments and finance operations." Again this should be a really interesting talk on a very topical subject –and it will be the first time that anyone from the PPF has spoken at TPNW.
