In 2011, she set up LegaCare, a charity that provides legal advice and support to vulnerable people affected by life threatening/terminal illness, working alongside the NHS who refer patients into the charity. Most of their clients are socially and/or financially excluded or simply don't have the energy to sort their affairs. Before then, as a solicitor Meg spent over 20 years advising the life and disability insurance industry. This should be a really fascinating insight into an area which we don't often cover.
