Cath Sermon is Head of Public Engagement & Campaigns for the Standard Life Centre for the Future of Retirement. She leads a programme of work that aims to further the evidence base for, & create, opportunities for people to achieve long-term financial security with a focus on saving, longer working lives and retirement. Prior to joining in 2022 Cath held various roles at working at the intersection of responsible business and social justice for the charity Business in the Community, latterly with executive team responsibility for campaigns & content.

Cath has been leading Standard Life Centre's work on targeted support and earlier this year she wrote an excellent article "Can Targeted Support help customers make better retirement income decisions?" The consultation period on the FCA's proposals in CP closed at the end of August and the FCA are now finalising the regulatory framework with a policy statement expected before the end of the year. So an ideal time for an update with Cath focussing on the impact from a consumer perspective.

"Pensions in the 2030s – Getting Ahead of the Big Issues"

Zoe is Executive Director of Policy and Advocacy at Pensions UK previously known as PLSA. Prior to joining Pensions UK Zoe was Director of Strategy and Corporate Affairs at Nest, the largest UK DC pension scheme by membership. Earlier in her career she worked in policy, strategy and operational roles at DWP and HMT including in roles supporting the Pensions Commission, as Private Secretary for pensions to two DWP Secretaries of State and helping to set up Pension Wise.

Zoe is also a trustee and non-executive director of Emmaus SLC, a charity supporting previously homeless people.

Coming on the back of Pensions UK's recent annual conference where Zoe was reported as pleading for the Pensions Minister Torsten Bell "not to go anywhere" her thoughts on the pensions landscape in the 2030s will be fascinating.

Liz needs no introduction as she is a regular attendee and contributor at our meetings. She is a partner at DWF LLP having advised on pensions law for over 10 years working in both international law firms and as part of a multi-disciplinary team in a Big 4 consultancy. Liz sits on the investment and DC sub-committee of the APL and over the last few years has advised a number of SIPP & SSAS providers and until recently advised UHY Hacker Young, the Joint Administrators of the Hartley pensions business. James was on our SIPP provider panel in May and has been MD of Alltrust for almost 3 years. He has over 15 years of experience in investment and asset management and is also MD & co-founder of UAP Group a multi jurisdiction pension, trust, corporate services and employee benefits firm. In their talk they will examine where the law/regulation creates challenges for providers and draw on their experience to compare the different approaches adopted by Pensions Ombudsman and FOS. They will also consider the likely impact of potential changes to FOS.
