"Design for Speed: what to do now about getting to the future faster"

I am delighted to welcome back to TPNW Belden Menkus of Menkus Associates. Belden has spoken at two previous TPNW meetings both on the subject of change and the chaotic world that we live in. On this occasion he will be providing us with some insight into a new initiative that he has been piloting through his business –"Design for Speed". To quote Belden: "Today, most organisational design tries to optimise the balance between (minimum) cost and (maximum) control, without an explicit focus on speed. However, for many organisations, speed is a growing issue: they aren't moving fast enough. This initiative will look at the ways organisations respond to emerging threats and opportunities with the intention of creating practical tools and approaches that allow organisations to quickly and effectively re-design themselves for speed." This should be a really thought provoking session whatever business you are in –and definitely not to be missed.
