Neil McIndoe Head of Environmental Finance Trucost, part of S&P Global

"Climate change risk to pension schemes"

Neil works with many UK pension fund clients on the footprinting of their equity funds and other assets to measure and manage climate change risk. Neil joined Trucost in 2003 and has been responsible for developing innovative carbon efficient financial products and indices. Starting with Merrill Lynch in 2007 these were the first products of their type in the world – but now are becoming mainstream offerings.

Neil has worked in Japan on the carbon data to support their \$10billion investment in carbon efficient Indices. In the UK Neil works alongside asset managers LGIM and UBS who manage the Future World and Climate Aware funds respectively. The Future World fund is the default DC scheme for HSBC Bank pension fund and the Climate Aware fund is used by NEST. Clearly climate change is very topical, and this should be a really interesting session so don't miss it.


Hannah Lewis Founder **Behave London**
