On this occasion I'm delighted to say that we have a third "honoured" figure from the pensions industry – Adrian Waddingham CBE - to talk to us. Adrian is the founding partner of Barnett Waddingham and spoke several years ago at an early TPNW meeting. He has been closely involved with the development of self-administered pension arrangements for directors of private companies since 1975. He was chosen as "Pensions Personality of 2010" by Professional Pensions magazine. Currently Adrian is one of two Sheriffs of the City London and as a consequence he currently resides in the Old Bailey! The main part of the role is to support the Lord Mayor of the City of London in promoting the City and in particular its financial services. Adrian will be telling us a little more about this role in his talk – definitely not to be missed.

"The Voice of the Beneficiary: Re-imagining Member Engagement in Pension Provision of the Future"

We start the second day with something a little different. Catherine Howarth joined ShareAction in July 2008. ShareAction is a groundbreaking charity that promotes Responsible Investment by pension funds and fund managers. Previously she had been the founder and lead organiser of West London Citizens. Earlier in her career she was Senior Researcher at the New Policy Institute.

Catherine is a board member of Green Alliance. She was a Member Nominated Trustee of The Pensions Trust (the multi-employer pension scheme for the UK's not-for-profit sector) for five years until Spring 2013. She served for four years on The Pensions Trust's Investment Committee. In 2013, Pensions Insight featured her as one of the 50 most influential people in pensions. Recently she's been doing a lot of work on the Law Commission's current review of pension fund's fiduciary duties. This should be a fascinating and very informative session.

“Pensions reform - lessons to be learnt from across the globe”

David is an internationally recognised authority on pension reform and proposition development and is well known in the financial services industries in the UK, USA and Australia as an expert on wraps and pensions systems and reform. David has worked for the financial services and consumer protection regulators in Australia and the UK and was awarded the AMP Churchill Fellowship to study “What influences public confidence in the life insurance and retirement industries”. It’s all too easy for us to forget that many of the issues that we’re grappling with in the UK are the same issues concerning other countries across the globe. Again David’s talk should be both educational and entertaining.
